Unity Council News

District 26 Unity Council met once again in Au Gres on January 18th to welcome in the new board members. There was a large and impressive showing of approximately 35 people that included visitors, GSRs and new service members. As impressive as the turn out was, there is still hope and a vision that at future meetings we will be welcoming GSRs from each and every group that meets within the district.

Discussion included a treasury report with a projected budget of \$3,311.00 for 2025. The prudent reserve will presently stay at \$750.00. During the 2024 year, a total of \$3,800.00 in donations was received from the groups within the district. The estimated expense budget for 2025 includes; \$300 for rent and \$240 for donut payments for district meetings, \$276 for the grasshopper line, \$220 for the website, \$25 for a tax document, \$250 for the district picnic and \$2,000 for 4 workshops throughout the year. During the meeting a request was submitted by the PICPC committee for \$100 to purchase literature to distribute in the jails and throughout the community. The request was unanimously approved along with praise for the committee members for bringing the message of AA to the professional community as well as those incarcerated.

The workshop committee reported on their progress regarding the upcoming Spirituality workshop. Amongst discussion was that the workshop would be available for viewing via a Zoom account that has just been purchased for District and the workshop use. Although there was concern regarding anonymity at the level of press, radio, films (and internet) that having the workshop on Zoom would not be violating that tradition as the workshop will not be recorded, anyone attending will know ahead of time that it will be an open meeting and accessible to people via Zoom. Discussion ensued regarding the Grasshopper line. It was determined that volunteers would be informed when their name was back up in the rotation to receive calls. Discussion also ensued regarding if they could have a list of resources to consult for referring callers to people and meetings within the area that they were calling from. No definite decision or plan of action was decided on at this point in time.

Groups were encouraged to submit a group history form to area 32 archivist, Jim D. Due to limited space and to save paper and ink, a group history form isn't going to be included here. One can be obtained by a quick Google search of "AA group history form". The newsletter editor, Holly C., will bring a few blank Group History forms to the next Unity Council meeting in Oscoda.

The final portion of the meeting was comprised of the individual reports by the GSRs in attendance. Many GSR's reported thriving groups. Of note was a GSR who reported his group thriving after doing a group inventory and following suggestions that were learned at "The AA Group; Where it all begins" workshop. Several groups requested extra support (See them listed in the "Stronger Together" section of this newsletter). Another group on the list reported a new energy in their group that formed a core group for a group conscience and brainstorming on changes to make to bring more life and vitality to their group.

The next District 26 Unity Council meeting will be held on March 15th in Oscoda at Grace Community Church, North Skeel Avenue, fondly referred to as "Grace on the Base". Coffee, donuts and fellowship will be at 9:30 AM with the meeting following at 10 AM. The hope is that even a larger group will attend with even more representation from every corner of the district.

The first meeting of the new year and new service members was a positive and hope filled hour and a half. There is an excitement and level of commitment to the ongoing health and strength of this recovery community. All are encouraged to attend our next meeting and the area meeting in Owosso on February 2nd.

Clear your calendars now and make your reservation to attend the next District 26 AA workshop on Saturday, March 22. The workshop committee has been hard at work planning the spirituality workshop using multiple pamphlets, the Big Book and the power of Zoom. The location will be the same as past workshops at the Hale Methodist Church, 201 W. Main St, Hale, Michigan 48739. New to this workshop is that it will be accessible via Zoom. The workshop will begin at 10 AM and will last until approximately 3 PM. Lunch and all workshop materials will be provided. As this is a district sponsored workshop there is absolutely no fee to attend and no donations will be collected. They are very strongly requesting that participants RSVP so that they have an accurate head count for both lunch and materials. Please contact Nick T at 810-730-3829 or online at dist26aa.org. Each participant will receive the book, "Came to Believe" and the three pamphlets that they will be referencing; "Where money and spirituality mix", "Many paths to Spirituality" and "The 'God' Word". In addition to these pamphlets they will be referencing the Big Book Appendix II, "Spiritual Experience".

Even more exciting than those materials are that speakers from many different faiths from around the world will be joining our group in Hale via Zoom for an approximate 15minute spot on their particular faith. Included in those religions covered will be Judaism, Hinduism, Buddhism, Christianity and *possibly* a Native American speaker. (Still in the works at the time of this printing).

Workshop member Amy S. hopes that a takeaway for attendees of this workshop is that they know that "no matter where you come from on the religious spectrum, you will find a God of your understanding". There are no limits or rules that can keep a person from grasping the spiritual principles of AA to lead to sobriety. For those attending that are quite comfortable in their religion or spiritual path, participation at this workshop might expand their beliefs or help them to better understand and communicate the message of recovery to the still suffering alcoholic that they may come in contact with.

Don't forget to RSVP, and if you can't come in person, join by Zoom. More than anything, bring an open mind and a desire to enhance your spiritual journey.
