The present Test Report is intended to refer only to the sample received in the Laboratory SICURAL and sampled directly by the Client who, under his own responsability, declares to be the same as indicated in the Request of Analysis. Recovery calculated in the verification phase of the official method or of validation of the internal method for detection of pesticides residues in traces, was found to be between 70% and 120% and not applied to the result unless specifically requested by the Client (in the latter case it is reported in the "Notes" space). Residual samples are stored for 20 days from the beginning of the analysis. Water samples are eliminated at the end of the analysis.
