General contract declarations of driver (driver = participant)

The participants are jointly and severally liable for all obligations under the entry contract.

The participants assure that

the information given in this entry is correct and complete,

they have fully met the requirements of the event (= untimely and timed training, qualifying training, warm-up, races, races to reach maximum speed),

the jetboat complies in all respects with the relevant technical regulations,

the jetboat can be inspected in all parts at any time by the technical commissioners and can

they will use the jetboat only in technically and visually perfect condition at the respective event.

that they exercise particular precaution when crossing the federal highway

You further declare by signing that they are covered by the UIM Rulebook with Appendices, the Legal and Disciplinary Provisions of UIM, the Anti-Doping Regulations of the International and National Anti-Doping Agency (WADA / NADA Code), the relevant DJSV regulations, the General Championship Rules and Special Provisions, the DJSV Environmental Guidelines and other UIM, DJSV regulations, and they will recognize them as binding and follow them.

In particular, you recognize as binding that

they have to accept facts in the person or the behavior of a team member (applicants, drivers, mechanics, helpers, etc.) who affect the contractual relationship with the organizer or justify a claim for damages.



the UIM, DJSV, its jurisdiction, the stewards and the organizers are entitled, among other things, to penalties for violations of the sporting rules, sporting law provisions and contractual obligations - as in the ISG, the regulations, tenders and other provisions - to be determined - without prejudice to the right to take action in accordance with the provisions of the ISG and the Regulations; they may not use any substances or methods as defined in the Prohibited List of WADA's World Anti-Doping Code and in the UIM Anti-Doping Provisions.

Protest and appointment

The participants (also several drivers named for a jetboat) authorize each other with submission of the nomination to represent each other in the protest and appeal procedure. In particular, they authorize each other to file protests, withdraw, announce, file and confirm, withdraw and waive the right to appeal and to file all applications that may be submitted in the context of the protest and appeal procedures, and to make or receive statements.

Statements by the participants to exclude liability

Participants participate in the event at their own risk. You are solely responsible under civil and criminal law for any damage caused by you.

You agree to waive all claims for damages incurred in connection with the event
