## Privacy policy

The protection of your personal data is important to us. For this reason, we inform you with this privacy policy about the use of your personal data.

The association In Harmony with Nature e.V., Marktstraße 11, 88677 Markdorf, board of directors Mrs. Stephanie Bunk (1.chairwoman), collects your data within the framework of the statutes of the association in the respective valid version.

The data collection and processing is necessary for the implementation of the statutory requirements and is based on Article 6 para.1b DSGVO. This concerns your contact data (such as name, address, telephone number, e-mail account) and your account data (account holder, bank details, account number), as also shown on page 1 of this membership form.

Your data will not be passed on for advertising purposes. Data will only be passed on to third parties within the scope of the necessary tasks/duties stipulated by the articles of association or due to legal requirements, e.g. the storage of donation confirmations in the event of an audit by the tax authorities.

Your data will be deleted as soon as they are no longer required for the purpose of their processing, e.g. when you leave the association. However, statutory retention periods will be taken into account and fulfilled.

You have the right to object to the use of your data for the purpose of newsletter information at any time.

In addition, you are entitled to request information about the data stored about you by the Executive Board of the Association and, if the data is incorrect, to request that it be corrected or, in the case of unauthorized data storage, that your data be deleted.

In the event of violations of data protection law, you have the right to lodge a complaint with the competent supervisory authority. The competent supervisory authority in matters of data protection law is the State Data Protection Commissioner of the Federal State of Baden-Württemberg.
