Old Business

Workshops & Conferences

Dick D. reviewed the background and development of the Anonymous Unity Council Survey that polled members attending local AA meetings to determine current details about what workshops and/or conferences the general membership would attend and support. Initial results of survey data received to date were presented and discussed. The major subjects requested included the 12 Steps; with a slightly higher preference for Steps 4, 11, and 12. Other frequently mentioned topics included Sponsorship, Acceptance, Higher Power, Open Talks, and Advice for New Members. Polling of members is still continuing. It is anticipated that a final report of survey results will be compiled in January or February of 2024 following the next Unity Council meeting.

Dennis B. reviewed the 5-session 4th Step workshop that is currently in progress. It is hosted and led by members of the Oscoda Keep it Simple Group. At the first session Dennis laid

out the workshop's general format and the attendees read aloud the relevant 4th step text in the Big Book. He also passed out materials used in previous workshops. Attendance at the workshop has been very good with between 15 to 20 people attending each of the first two Thursday evening sessions.

A general discussion of workshop subjects and their selection for funding by the Unity Council followed these presentations. Subjects included:

- 1. Written materials vs. in person presentations.
- 2. AA experience is that success in holding these events depends on the personal involvement of at least one AA member.
- 3. Young AA members
 - There is a need for providing topics and/or formats that appeal to younger AA members.
 - There is a need to encourage young people to participate in the development of workshops and conferences. They could make up a body of experienced members that can be the basis of a healthy educational future within the District/Area.

Dennis B. made a motion to approve spending as follows: \$800 to Central Michigan and \$400 to New York. Motion seconded by Jerry P.
