# ALLIANCE STA attended MaaS Alliance annual meeting

The STA was invited to attend the MaaS Alliance annual meeting in June 2020 following the signing of the common Memorandum of Understanding earlier this year. The STA Chair, Mr John Verity gave a presentation on the work of the STA highlighting also its international connections with Japan (JR East) and US (APTA). The cooperation between the STA and the MaaS Alliance has been welcomed and encouraged by the European Commission during their intervention, while emphasising at the same time that public transport is the backbone of the mobility chain.



Five questions to... Dr Dominik Elsmann, Head of the

### department for cross-border public transport, Aachener Verkehrsverbund GmbH

# What are your main activities during weekdays?

Communication, coordination and project management determine my daily work. In my position as head of the department for crossborder public transport at Aachener Verkehrsverbund (AVV), I'm responsible for the coordination with my counterparts on the Dutch and Belgian side as well as the coordination with all project partners with whom we cooperate on international projects.

#### Why did you join the STA?

Aachener Verkehrsverbund (AVV) is based in the heart of a border region. The recent past has shown how challenging the establishment of ticketing systems that meet the requirements of all regions can be. Many opportunities are opening up in the context of digitisation, but only a well-coordinated approach will lead to good and sustainable results. The STA offers the possibility to exchange with colleagues from other countries, to discuss potential solutions, to learn from each other and to take promising solutions in the right direction.

#### What do you expect from the STA?

Being responsible for cross-border public transport in a border region consisting of three countries, I have experienced many times how difficult it can be to establish new mechanisms in public transport. Recognising that the organisation and financing of public transport varies from country to country, in many situations intense coordination is necessary to align processes. I expect the collaboration within the STA to pave the way for a harmonised and interoperable development in the field of ticketing and to make boundaries disappear that are still evident today.

#### How will you contribute to its success?

We've worked quite intensively on finding solutions for interoperable cross-border ticketing in the last years. With the achievements of the finalised project "European Travellers Club (ETC)" and the recently started new project "easyConnect", we're contributing to finding ways how seamless ticketing can be realised. An account-based ticketing (ABT) approach is most promising from our point of view and therefore the focus of the pre-mentioned projects. Experiences and results are fed into the working groups of the STA in order to take them further.

# What do you wish for the future mobility of Europe?

For passengers it should be as easy as possible to travel wherever and however they want. Borders shouldn't prevent people from travelling from A to B and technique should help to make their travel experience as seamless as possible. By continuing the promising work of recent years, I look forward to this future very positively.
