



## **Terms & Conditions**

### **Payment:**

Payment to be made directly to our bank account. Alternatively, cheques to be made payable to: **Heliotrope Yoga Holidays Ltd.**

We require a **£150** non-refundable deposit per person. A place on the course is not reserved until we have received cleared funds. If you book a share of a twin room and, despite our best efforts to find you a suitable person to share with, none is found by two weeks before the start of the holiday, then we will ask you to pay a single supplement.

Full payment is required at least two months before departure. Provided there is space, bookings can be accepted until the date of departure, but for bookings within two months of departure, immediate payment in full is required.

### **Cancellation by you**

Cancellation incurs the following charges:

Up to 3 months before departure – loss of deposit

Up to 2 months before departure – 50% of total fee

Up to 6 weeks before departure – 100% of total fee

Cancellation fees are often covered by holiday insurance: we recommend you take this out at the time of booking.

Notification of cancellation of the holiday must be given by email to the following address: [contact@heliotrope-yoga-holidays.com](mailto:contact@heliotrope-yoga-holidays.com). Failure to do so immediately may prejudice your entitlement to claim a refund. No refunds can be made once participants are in their place of destination.

### **Cancellation by us**

In the event of the teacher(s) being unable for any reason to teach the yoga holiday, we will use our best endeavours or find a replacement teacher with similar qualification and experience. If such a teacher is not found a full refund will be given.

### **Descriptions:**

All information included in our brochure and website is correct to the best of our knowledge at the time of going to press. However, due to staff cancellations, weather conditions, low bookings, maintenance work, mechanical faults, or other situations outside our control, some amenities or courses described may become temporarily or permanently unavailable.
