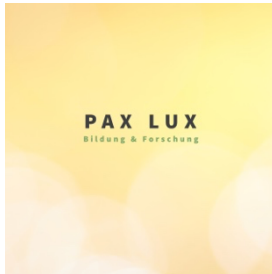

OUR GENERAL TERMS AND CONDITIONS

REGISTRATION

Each registration is binding. Registration must be made in writing (e-mail, by post). For registrations by e-mail or post, please use the registration form on our homepage. In order to process your registration, we need your complete data and your signature. If you are under 18 years of age, registrations must be signed by your legal guardian. The registration will be confirmed by the Pax Lux Association.

COURSE FEE AND OTHER COSTS

The course fee and other costs can be found on our homepage. These are due within 7 days after sending the invoice.

CONFIRMATIONS

An entitlement to the issue of a confirmation of participation exists if at least 70% of the specified course hours have been attended and the course fee including other costs has been paid.

CANCELLATION AND CANCELLATION FEES FOR IN-HOUSE PROGRAMMES

When booking a course or an event, in the case of a consumer transaction within the meaning of the Consumer Protection Act, you have a statutory right of withdrawal within a period of 7 working days (Saturday does not count as a working day), calculated from the day of conclusion of the contract, unless the course begins as agreed within these 7 working days from conclusion of the contract. No cancellation fees will be charged for exercising this right of withdrawal. The withdrawal period shall only be deemed to have been granted if the declaration of withdrawal is demonstrably received by us in writing or in person within the period. A cancellation fee must be paid for the withdrawal, which in the case of a cancellation from the 30th day up to the 15th day before the start of the course amounts to 50% of the agreed course fee, from the 14th day up to the 2nd day before the start of the course 75% of the agreed course fee and in the case of cancellations at even shorter notice 100% of the agreed course fee. Cancellation is only effective when we have received proof of the cancellation in writing or in person. The cancellation fee is due upon effectiveness of the declaration of withdrawal and is payable irrespective of the reasons for withdrawal and any fault.

CANCELLATION AND CANCELLATION FEES FOR OPEN COURSES AND OPEN SEMINARS

A cancellation fee is payable for open courses and open seminars. In the event of cancellation up to the 15th day before the start of the course, this fee amounts to 50% of the agreed course fee, and in the event of cancellation at even shorter notice, 100% of the agreed course fee. Cancellation is only effective when we have received proof of the cancellation in writing or in person. The cancellation fee is due upon effectiveness of the withdrawal declaration and is payable irrespective of the reasons for withdrawal and any fault.
