The Competition will be held from 23 to 25 April 2022 in Mogliano V.to (Treviso), Italy.

Art. 2 - For all competitors, the contents of performance are free to choose and it may include one or more pieces of a different character.

In the event that the repertoire includes a piece by J. S. Bach and Ugo Amendola also competes for the assignment of the special "Guido Novello" prize; the performance of the piece by J.S. Bach or Ugo Amendola allows the competitor to exceed the total execution time foreseen for the category of 5 minutes.

Performing by heart is not mandatory.

The competition is divided into the following categories:

Cat. Prime Note born after 01-01-2014 Maximum duration of the test: 4 minutes.

Cat. A born from 01-01-2012 to 12-31-2013 Maximum duration of the exibition: 5 minutes.

Cat. B born from 01-01-2009 to 12-31-2011 Maximum duration of the exibition: 7 minutes.

Cat. C born from 01-01-2006 to 12-31-2008 Maximum duration of the exibition: 10 minutes.

Cat. D born from 01-01-2003 to 12-31-2005 Maximum duration of the exibition: 20 minutes.

Cat. E born from 01-01-1999 to 12-31-2002 Maximum duration of the exibition: 25 minutes.

Cat. F up to and including 30 years. Maximum duration of the exibition: 30 minutes.

Cat. G *piccolo* (with and without piano accompaniment) up to and including 30 years. Maximum duration of the exibition: 15 minutes

Art. 3 - Each competitor can subscribe to only one flute category, in category G (piccolo), or in two categories, one of which is flute and the other category G.

Art. 4 - Competitors can enroll in a higher category if they believe that their preparation allows it, but not in a lower category. The Overall Winners of the category will not be able to participate in the competition of the following year.

Art. 5 - Competitors must show, while rehearsing, an identification document.

Art. 6 - Appropriate clothing is required during the auditions.

Art. 7 - The Juries may:

- ask the competitor to perform the whole program or only a part of it if the established time has been exceeded;

- not assign any Prizes or Scholarships if the level of execution are insufficient. The Juries's judgement is unquestionable and unappealable.

Art. 8 - Candidates who in the last two years have had continuous teaching relationships with members of the Commission or who are related to them cannot subscribe to competition. In the registration form it is mandatory to indicate the name of your teacher.

Art. 9 – For each category, the absolute winner will perform at the prize-giving concert on Monday 25 April in Mogliano V.to only if the results are equal or higher than 98/100. Candidates who won't be able to perform will automatically be ousted from the competition.

Art. 10 - The organization provides a grand piano for auditions and the places and times for the practice and rehearsal rooms will be communicated at the beginning of the competition.
