

Conditions of participation for the fundraising campaign "15.000 euros for a good cause"

1. Acceptance of the conditions of participation

By participating in the fundraising campaign "15.000 euros for a good cause" organized by incantis GmbH, the participant/applicant expressly and bindingly acknowledges the following terms and conditions of participation.

2. Eligibility

Only natural persons of legal age are eligible to participate. Minors are excluded from participation. A donation payment to minors is excluded.

3. Promotion period

The promotion starts on sunday, September 01, 2024, and ends on monday, September 30, 2024. During this period, participants can apply by e-mail at charity@incantis.de . All e-mails received during this period will take part in the selection process by incantis GmbH.

4. Process and selection procedure

Participants apply representative of a registered non-profit association from the city or district of Bayreuth. This application is to make exclusively by e-mail to charity@incantis.de or the corresponding link on the homepage www.incantis.de. In your e-mail, you leave your surname, first name, address, e-mail and the telephone number where you can best be reached during the day, as well as the name of the association for which you are applying, as well as the intended purpose of this donation. From the applications received during the campaign period, the selection of donation recipients will be determined at the judgment of incantis GmbH. Depending on the quantity and scope of the applications actually received, not every application can be considered for the donation distribution and may also be decided according to criteria such as purpose, target group, application receipt or even randomly. The participation is free of charge. Communication with incantis GmbH by e-mail, Internet, telephone or post may cause costs for online services, telephone provider or postal charges.

5. Donation amount and donation receipt

The selected recipients of donations will receive an amount of € 500.00 for their association. After the selection process has been completed, the donation amount will be transferred to the official association account of the identified associations. incantis GmbH may demand that the representative of the association proves his identity by submitting suitable documents. In case of doubt and discrepancies, incantis GmbH decides to the best of its knowledge and belief. The registered association that receives a donation from incantis GmbH undertakes to issue and transmit an official donation receipt for incantis GmbH recognized by the tax office as soon as the donation amount has been received in the association's account.

6. Consent to the publication of personal data and photos

The selected associations, possibly represented by one or more official representatives, expressly declare their willingness to be available for photo/image/video and text promotions within a reasonable framework. By participating, each participant agrees that his or her surname, first name, place of residence, association and (recorded) statements as well as photos taken during the formal handover of the donation with his or her image – possibly also as a moving image – in connection with the fundraising campaign by incantis GmbH in press products (such as daily newspapers, community newspapers, weekend newspapers), as well as under www.incantis.de or on social media such as linkedIn and instagram, or made publicly available.

7. Exclusion of participants

incantis GmbH reserves the right to exclude participants – even after the end of the campaign period retrospectively – in the event of violations of these terms and conditions of participation, (attempted) influence of any kind and extent (manipulation) or obvious lack of a serious intention to participate. Incomplete information or false information about eligibility, association, surname, first name, address or telephone number entitles incantis GmbH to exclude the participant as a violation of these terms and conditions of participation. With the exclusion, any entitlement to the payment of donations expires.

8. Privacy

By participating, the participant agrees that incantis GmbH will store the necessary personal data for the duration of the campaign and use it exclusively for the purpose of determining the recipient of the donation and the processing of the donation. The data will not be passed on to third parties and will be deleted after the end of the donation processing or after clarification of disputed questions (preservation of evidence).

9. Cancellation of the fundraising campaign

incantis GmbH reserves the right to cancel or terminate the fundraising campaign at any time. This applies in particular in the event of force majeure or if the promotion cannot be carried out or continued for other organisational, technical or legal reasons. In such a case, the participants are not entitled to any claims against incantis GmbH.

10. Legal recourse

The legal recourse is excluded.

11. Disclaimer

incantis GmbH is not liable for technical problems or for damages due to malfunctions of technical systems, for delays or interruptions of transmissions or for damages in connection with participation in the fundraising campaign or with the acceptance and/or use of the donations, unless incantis GmbH or its vicarious agents act intentionally or with gross negligence. This does not affect any claims for compensation due to injury to life, limb and health as well as essential contractual obligations.

12. Ratio of verbal information / written conditions of participation

If verbal information deviates from the above terms and conditions of participation in terms of content, the provisions of the terms and conditions of participation shall apply exclusively with regard to the deviating information.

13. Written form requirement / severability clause

Changes and/or additions to these terms and conditions of participation must be made in writing in order to be effective. This also applies to the waiver of the written form requirement itself. Should one or more of the above clauses be or become void, invalid or unenforceable in whole or in part, the remaining terms and conditions shall remain valid. It is replaced by a correspondingly valid clause. The same applies if there is a regulatory loophole. Collective terms used such as employee, participant, donation recipient, representative or others apply equally to women and men and are therefore to be regarded as gender-neutral. The masculine form of the designation was chosen exclusively for reasons of better readability.
