### Duration of processing:

Your data will be deleted as soon as the purpose of the processing ceases to apply and there are no statutory retention periods conflict with this.

The legal basis for the processing of personal data is the declaration of consent you have signed declaration of consent pursuant to Art. 6 para. 1 p. 1 lit. a) DSGVO.

In accordance with Art. 15 DSGVO, you are entitled at any time to ask ONE WORLD PROJECT e. V. for extensive information about the data stored about you.

In accordance with Art. 16 DSGVO, you may at any time request ONE WORLD PROJECT e. V. to request the correction of individual personal data.

In accordance with Art. 17 DSGVO, you have the right to have your personal data deleted.

In addition, you can demand the restriction of processing at any time under the conditions of Art. 18 DSGVO restriction of processing at any time.

Pursuant to Article 20 of the GDPR, you have the right to receive the personal data concerning you that you have provided to a controller in a structured, common and machine-readable format.

You can also exercise your right to object pursuant to Art. 21 DSGVO at any time without giving reasons right to object in accordance with Art. 21 DSGVO.
