



Terms and Conditions and Privacy Policy for 1x Senseforce Pad Extreme from 21.02.2020 (18:00) to 20.03.2020 (23:59) German Time

1. Participation

a) Persons worldwide are eligible to participate. Minors require the consent of their legal guardian to participate, unless this is expressly excluded. Employees of iFeel Tactile Systems GmbH and their relatives are excluded from participation. Participation by means of electronic registration systems, so-called collective service providers as well as so-called disposable e-mails or trash mails, is not taken into account.

b) A person participates in the Contest by making a Like and comment on the respective post on Facebook, or/and Instagram. Multiple participation is excluded.

c) The processing of the necessary personal data is used exclusively for the purpose of conducting the competition. The winning data will be transmitted to iFeel Tactile Systems GmbH and, if applicable, to a shipping service provider for the purpose of the profit processing. In addition, the data will not be passed on to third parties. All data will be stored for a period of 90 days from the end of the entry deadline of the competition and will then be deleted, unless there are any statutory retention obligations. 2. Implementation and settlement

Privacy policy

1. Responsible body and data protection officer iFeel Tactile Systems GmbH Ebrardstraße 72, 91054 Erlangen, represented by the management ("we") is responsible for the data collection and use in the context of the competition. The contest is held under German law.

2. Purpose and legal basis the data processing takes place for the purpose of the performance of the respective competition. The legal basis is therefore Article 6(1) of the lit. b Old. 1 of the General Data Protection Regulation (GDPR).

3. Data categories concerned We only process the data that is necessary for the performance of the competition or which you provide in the context of the competition.
