



FORMULA KARTING

TERMS AND CONDITIONS 2021

Art. 1) Release & waiver of liability, assumption of risk and indemnity

- 1.1 When you participate in Formula Karting this is entirely at your own risk or the risk of your parent/guardian if you are younger than 18 years.
- 1.2 Spectators watch at their own risk. This concerns any person who enters the race location or part of the circuit, including the pit lane.
- 1.3 Children who are spectators must be under the supervision of an adult at all times.
- 1.4 Formula Karting can not be held responsible for any accidents or injuries during race activities.
- 1.5 We reserve the right to refuse access to the race location to anyone we find a risk to the safety of themselves or anyone else.

Art. 2) General entry requirements

- 2.1 For participation in Formula Karting a minimum age of 15 year and height of 155 cm is required and without extra lead the driver must weigh with full equipment at least 60 kg.
 - 2.1.1 For participation in Formula Karting Junior a minimum age of 10 year and height of 150 cm.
 - 2.1.2 For participation in Subdivision 'Heavyweight' a driver must weigh at least 80 kg.
- 2.2 Proof of age may be requested to verify compliance with the age restrictions in the above-mentioned article.
- 2.3 Any driver who can not present a valid identity card at the request of the organization will not be admitted to the race.
- 2.4 Drivers can ask for dispensation, but recent competition or driving experience will be required and then FK will decide in consultation with the kart tracks whether the driver can take part in the championship.

Art. 3) Medical limitations

- 3.1 You confirm that you do not have a medical condition that would prevent you from driving the races.

- 3.2 You have told us that there are no other medical conditions that are of importance, so that we can advise you whether the races are suitable for you. These include, but are not limited to: heart disease, back injury, epilepsy, amputations, artificial limbs, auditory or visual impairment, or any form of mental or physical impairment.
- 3.3 You understand that if you exceed the rules regarding the height and weight for which the karts are normally designed you are not able to participate. As a general guide: drivers over 200 cm or 120 kg must request permission prior to the race so that we can assess suitability.
- 3.4 Participation when you are pregnant is not allowed.

Art. 4) Behavior and compliance with rules

- 4.1 The driver is obliged to be present at the safety briefing and to comply with the established rules and guidelines.
- 4.2 The driver understands that the organization expects the driver to comply with the rules for the safety of all participants, spectators and employees and that failure to comply with these rules will lead to disqualification.
- 4.3 In case of disqualification of the racing day there will be no refund of registration fees.
- 4.4 The organization reserves the right to end or remove sessions from the day program if the safety of the participants, spectators or employees is compromised.

Art. 5) Payment

A For the entire 2020 season

- A.5.1 For a registration for the entire season a registration fee applies. This amount consists of race one and a deposit of € 10,- per remaining race.
 FK Benelux €125,- + €70,- (7 x €10,-) = € 195,-
 FK Belgium €110,- + €70,- (7 x €10,-) = € 180,-
 FK Nederland €100,- + €70,- (7 x €10,-) = € 170,-
 FK Nederland Junior €75,- + €70,- (7 x €10,-) = € 145,-
- A.5.2 The registration fee must be credited to the bank account of Formula Karting by Friday May 28th, 2021 at the latest.
- A.5.3 Once confirmed by the organization and after receiving your payment, you are definitively enrolled for the entire season.
- A.5.4 From race two onwards, the driver must ensure that the remaining amount is credited to Formula Karting's bank account no later than 10 days before each race.

B Individual races

- B.5.1 The entry fee for a single race must be credited to the bank account of Formula Karting within 5 days of registration.
- B.5.2 After receiving your payment, you are finally registered for the race.

- B.5.3 The person who transfers the payment to the organization is responsible for correctly stating the details of your reservation for the relevant race.
- B.5.4 Also as in art. 4.2 this provision also serves as a confirmation that you have read and understood the General Terms and Conditions and the Formula Karting Regulations. You must comply with this.
- B.5.5 All prices are including VAT.

Art. 6) Unsubscribe and refund after payment

- 6.1 If a driver cancels up to ten days before a race day, there will be a refund of the registration fee minus € 10,- to his or her account.
- 6.2 If a driver cancels within ten days before a race day, there will be a refund of the registration fee minus € 40,- to his or her account.
- 6.3 If a driver doesn't sign out, there will be no refund.
- 6.3 Only if a driver has a well-founded reason for canceling the refund will be assessed on a case-by-case basis. FK can possibly ask for proof.

Art. 7) Promotion purposes

- 7.1 When participating in FK, the driver agrees to the use of photo and film recordings for promotional purposes (posters, flyers, banners etc ...).
- 7.2 The driver also agrees to the use of photo and film recordings on the Formula Karting website's and various social media platforms (Facebook, Twitter, Instagram etc ...).
- 7.3 No rights can be derived from the use of photo and film recordings by FK.

Art. 8) Privacy

- 8.1 All personal information provided by the drivers remains with the organization and will therefore not be made available to third parties.
