STA published Glossary

The STA has developed a Glossary of Terms and Abbreviations used in the Public Transport Ticketing Industry.

With the aim of demystify some of the jargon used in the Public Transport Ticketing Industry, particularly relating to Smart Ticketing, the Glossary has been drawn-up so that

- persons who have experience in the Public Transport Ticketing Industry use terms with the same meaning and avoid different interpretation of terms and misunderstanding
- persons who are new to the Public Transport Ticketing Industry have ready access to a document that explains the meaning used generally within the industry.

The Glossary will be updated on a regular basis and published on the STA website.



Joint UITP & STA Ticketing in MaaS Working Group continues in full swing

Following the launch of the joint working group between the UITP and the STA on Ticketing in MaaS, a report will be drafted that will incorporate the discussions around trust in ticketing. Trust is crucial as a basis for cooperation between organisations and cuts across every cooperation between mobility partners and is just as important for the travelers not least in view to mobility behaviour changes. Interview with STA members: Guido Di Pasquale, Deputy Director of UITP's Knowledge & Innovation department

What are your main activities during weekdays?

UITP is involved in many research and innovation projects: we believe that to develop the integrated sustainable mobility systems of the future, our sector must continually invest in Knowledge and Innovation.

As Deputy Director of UITP's Knowledge & Innovation department, it is my job to keep up to date with any developments in the field of knowledge production and facilitate knowledge-exchange and collaboration with our members and within the broader mobility field

As expert in the fields of ITS, ticketing, Mobility as a Service, and automation, I coordinate many of our projects on these topics, as well as align the UITP strategy to reflect the latest trends and developments.

Why did you join the STA?

UITP was one of the co-founders of the STA in 2015. As an association we represent the entire public transport sector: authorities, operators, industry, policy makers and scientific institutes. In fact, we are the only association of our kind in the world to represent all players within our industry.

Among these players, we saw the need to enhance and harmonise the Smart Ticketing ecosystem.

Seamless, door-to-door mobility starts with planning the journey and offers free choice and safe payment options to the traveller. Ticketing is no longer a simple part of the public transport experience: it an essential part of a broader mobility solution and the gateway to freedom to move around. By cofounding the STA, we wanted to promote the cooperation between national and regional Smart Ticketing players, ultimately to establish an interoperable 'Smart Ticketing' and achieve excellence in passenger experience.

What do you expect from the STA?

By exchanging with many other institutions and companies on the evolution of ticketing and sustainable mobility, the STA can serve as a central reference point and steer the different interests from the sector in a way that takes everyone's needs on board. This will in the end better meet the needs of operators and passengers everywhere.

How will you contribute to its success?

UITP works together with stakeholders from the entire public transport sector, therefore representing different perspectives. In STA we hope to align these towards common actions and initiatives. For example, earlier this year we launched a new Working Group on Ticketing in MaaS. This is a collaboration covering the entire Ticketing value chain and producing comprehensive knowledge on a topic that is essential to enhance passengers experience and our sector as a whole. In addition, we launched a new strategic project called 'Urban Mobility Open Payments Forum', bringing together major players of the open loop payment industry, PTOs and PTAs.

UITP also harbours a great deal of knowledge when it comes to the world of ticketing. By regularly launching publications on the topic, such as the recent 'Demystifying ticketing and payment in public transport', we contribute to building and sharing knowledge on ticketing.

What do you wish for the future mobility of Europe?

Public transport is and should always remain

the backbone of urban mobility, yet our sector needs to continue to invest and innovate to keep meeting the needs of passengers. Digitalisation, smart ticketing: they deserve the right resources to make public transport more convenient, accessible and attractive. If we continue to nurture public transport, we achieve a future with clean air, a future that allows for freer movement in cities, and a future with easier and more inclusive access to jobs, businesses, education and culture.
