
#### 10. Features of Graduate School

## Features of Hokkaido University

Founded in 1876, Hokkaido University is one of the leading research universities in Japan. The graduate program is organized into 19 academic schools, including economics, literature, law, medicine, agriculture, science, and information technology. One of our faculty members, Prof. Akira Suzuki, won the **Nobel Prize in Chemistry** in 2010.

We take pride in our spacious (1.8km2) and beautifully maintained main campus near the heart of Sapporo, where approximately 18,000 students study and conduct research. Students come to Hokkaido University from all over the world: currently 1,200 students from 85 countries are enrolled at Hokkaido University.

Sapporo, with its population of a little less than two million and located on the island of Hokkaido,



is the largest city in north of Tokyo. Though the city is quite urban we have easy access to peaceful mountains, lakes, coastlines and beaches. Students enjoy various cultural events and activities held on campus and in the city throughout the year, and great outdoors hiking/cycling in summer and skiing/snowboarding in winter.

#### Features of Graduate School of Economics and Business

The Graduate School of Economics and Business Administration is just an eight-minute walk from JR Sapporo Station. Its lush green campus with 18 graduate schools and other institutions forms a nationally unparalleled environment where

academic facilities coexist with government offices and private enterprises.

## Interdisciplinary

The Graduate School of Economics and Business Administration provides students with a wide range of opportunities not only to engage in specialized research programs in economics and business administration but also to pursue a variety of intellectual activities regardless of their academic fields, places of origin or nationalities. Hokkaido University has 12 undergraduate schools as well as 18 graduate



schools and other institutions covering almost all academic disciplines. The majority of these schools and institutions are located on a single campus, allowing students to take related subjects offered at graduate schools in humanities (e.g., law, literature and pedagogy) and science (e.g., medicine, engineering, information science, science and agriculture). As such, the Graduate School of Economics and Business Administration offers the ideal environment for students to broaden their horizons by tapping into the interdisciplinary networks that only a university of this caliber can provide.

#### Multifacility

The Graduate School of Economics and Business Administration is equipped with air conditioning and heating systems, laboratories with network facilities, a computer room, a library, a printing room, lockers for individual students, and a student lounge. Additionally, the lecture building includes lecture/rooms with multimedia equipment and a workstation lounge. The campus has (a total of) 17 libraries (one of the largest collections of books in Japan), more than 10 cafeterias, 2 bookshops, 2 dormitories, the Hokkaido University Hospital, the Health Care Center, the Sports Training Center, and the Hokkaido University Museum, which all serve to support students' intellectual pursuits and research endeavors. The Hokkaido University Tokyo Office in the city's Marunouchi district provides enhanced mobility to faculty members and students alike by offering access to Internet connections and meeting spaces in the heart of the nation's capital.

#### **Nature and Urbanism**

The main campus of Hokkaido University is nestled in central Sapporo – a city with more than 1.9 million residents. Despite its location directly in front of Sapporo Station, it maintains the feel of Hokkaido's pristine, unspoiled natural environment with its lush green urban oasis. The Graduate School of Economics and Business Administration is located near the bust of Dr. William S. Clark (the university's founder) and a clear stream that flows idyllically among trees and over vast expanses of lawn. Outside the campus, however, is an energetic urban space that never sleeps, teeming with activity related to the Hokkaido Government Building, other government offices, main and branch offices of private enterprises, department stores and hotels. This environment acts as a reminder that the graduate school is the nearest of all those on the campus to JR Sapporo Station. The Graduate School of Economics and Business Administration offers a place where students can devote themselves to their research on a verdant campus with a rich history in close proximity to a major dynamic hub of administration, business and commerce.

## 11. Features and Curriculum of Program

Approximately 50 faculty members conduct diverse research in the fields of economics, econometrics, business administrations, and accounting. The school atmosphere is very collegial providing graduate students ample opportunities to interact with faculty members and conduct interdisciplinary research. For each foreign graduate student a Japanese tutor will be assigned to assist him/her in assimilating to Japanese university environment.

## Principle policy of the program

Hokkaido and Africa are struggling against similar development problems: deficit budget, trade deficit, agricultural depression, insufficient manufacture sector, dependency on public works, income differentials, overpopulation of the capital, depopulation of rural areas, brain drain, etc.

With this problematic, we propose international students as follows.

- (i) Learning theories and methods based on macroeconomics, microeconomics and applied economics as essential tools to solve problems.
- (ii) Based on a particular interest of a fellow, learning applied economics and writing a research paper under the supervise of an advisor
- (iii) Constructing a network with 30,000 students, including 1,500 international students, local business persons and civil servants, who face to similar local development problems as Sri Lanka.

#### Expected outcome of the program

- (i) Mastering specialized tools to plan and practice socio-economic development policies based on economics
- (ii) Mastering specialized and interdisciplinary knowledge to solve a development problems
- (iii) Constructing a human network with future leaders in 18 different majors and local business persons and civil servants, who face to similar development problems.

#### 14. Facilities and Cultural activities for International students

#### (1) Student Dormitory

Hokkaido University has 642 rooms in 6 dormitories and 44% of international student lives in a dormitory. This percentage is the highest in the national universities of the same scale in Japan. All new students can live in a dormitory at least six months, so that students do not have to worry about looking for a place to stay upon arrival in Sapporo. All of Hokkaido University's dormitories are located within walking distance from Sapporo Campus, and are fully furnished with internet access.

## (2) Japanese Language Program

The International Student Center offers Japanese Language classes in various levels from introductory level for beginner to advanced level aiming for job hunting. Classes are offered at 10 levels: Introductory 1/2/3/4, Intermediate 1/2/3 and Advanced 1/2/3. International students can choose classes from 6 types of units: Grammar, Kanji/Vocabulary, Oral Skills, Written Expressions, Reading Comprehension, and Listening Comprehension. Class level will be determined based on the placement test score. ## (3) Homestay Program

Students can apply for "Home Sweet Homestay" program conducted by Sapporo International Communication Plaza through Hokkaido University at all times of the year. Students can stay with a family in a specific region of Hokkaido and have meaningful relationship with ordinary Japanese family for a maximum of six days and five nights. Sapporo International Communication Plaza offers a homestay program for new arrival students and students can also apply for it through Hokkaido University.

## (4) Cultural Tour

'Zen Seminar'is a cross-cultural program, conducted by the Office of International Affairs in spring and autumn. In this program, international students and Japanese students from Hokkaido University spend two days together at a temple and hold various group activities, focusing on cross-cultural understanding. In addition, students also take part in Zen meditation and Japanese culture experiences.

The Office of International Affairs also offers a two-day trip called 'Holiday in Hidaka'. It aimed at international communication between Japanese and International students of Hokkaido University, in the relaxed and beautiful setting of Hidaka.

## 15.Message from the Dean



"Study Economics to Avoid Being Deceived by Economists"

"The reason to study economics is not to be deceived by economists," said Joan Robinson, a well-known British female economist. There are many opportunities to see scholars and critics discussing the economy and making policy recommendations in newspapers or on television. Sometimes the government even implements these policies. However, if such a policy is implemented, it is the people of us who are affected by such policies. To avoid such a situation, that is, to protect ourselves, we must know in advance the consequences of the policies implemented by the government. This is why we need to study economics that Joan Robinson mentioned above.

The term "economy(経済)" stands for "経世済民(Keisei Saimin)", an idiom meaning "to manage the world and to save the people." Economy is originally a concept that expresses

not only being restricted within the scope of economics, but also "improving the world (society as a whole) and making people better off." To achieve this line, the Faculty of Economics and Business and the Graduate School of Economics and Business cover and offer a very wide range of fields, including economics, business, accounting, operational research, and statistics. It is precisely an academic institution that 'lead's society as a whole for the better and makes people happy'.

Modern society is becoming more and increasingly complex and changeable. Our graduate school, department, and faculty has also changed in response to the needs of the times. In 2000, we established a research-led graduate school system through the emphasis on graduate schools, and since 2004 we have participated in the Hokkaido University Public Policy School together with the Faculty of Engineering and the Faculty of Law. In 2005, we established a Hokkaido University Accounting school. In 2011, we established the Center for Regional Economic and Business Networks, which has been engaged in global research on regional economy and business, and strengthened our support for local communities. In addition, from 2018, we established a double degree program for master's programs with three overseas universities in Sweden, Korea, and Taiwan, allowing them to obtain master's degree from a partner university and one from Hokkaido University. Under the early completion course system for undergraduate students, students can complete the undergraduate program and master program in five years. Furthermore, from 2017, the faculty members of Graduate School of Economics and Business Administration, which are engaged in research, and the Graduate School of Economics and Business Administration, which provides graduate education, were reorganized into Graduate

School of Economics and Business for graduate education institute, and Faculty of Economics and Business as research institute. Along this reorganization, we have also participated in establishing Graduate School of Global Food Resources with other research institutes including Faculty of Agriculture. At this graduate school, all classes are taught in English as in early years of Hokkaido University led by Dr. Clark.

Since our society is complex and changeable, academic knowledge to understand its essence is becoming more and increasingly important. I greatly hope that students with such high aspirations will come, visit, and enter to the Graduate School of Economics and Business or Department of Economics, such as "I won't be deceived by economists", and "I want to acquire academic knowledge to lead the society in a better direction and make people better".
